I am writing to respond to your request [REDACTED] December 2015. Oxford University Hospitals NHS Foundation Trust can confirm that it holds the data that you requested.

Please find the answers with patients identified with FGM (Female Genital Mutilation). Patient data pertaining to obstetric patients with FGM is identified at this point of birth, and in most cases patients will be over 18s. The table below has included over 18s as per Trust data collection.
