## **Executive Summary**

- 1. This paper provides a report on the Trust's preparedness for emergencies for 2022/23 and 2023/2024 YTD.
- 2. The report discusses the planning progress over the past year, looks at the training and exercising programme, and gives a summary of instances in which the Trust has had to respond to extraordinary circumstances.
- 3. Divisional progress on developing and updating service continuity plans requires ongoing focus. This is being done through monthly reporting to executive and divisional teams, and through bi-monthly reporting to the Health and Safety Committee. The following services with red rated service continuity plans are being addressed as noted below:

## **Emergency Preparedness, Resilience and Response Annual Report**

## 1. Purpose

- 1.1. This paper provides a report on the Trust's emergency preparedness to meet the requirements of the Civil Contingencies Act (2004) and the NHS England Emergency Preparedness, Resilience and Response Framework (EPRR) 2022.
- 1.2. The Trust has a mature suite of plans to deal with Major Incidents and Business Continuity issues. These conform to the Civil Contingencies Act (2004) and current NHS-wide guidance. All plans have been developed in consultation with regional stakeholders to ensure cohesion with their plans.
- 1.3. The paper reports on the training and exercising programme, the EPRR reporting programme, and the development of emergency planning arrangements and plans. The report gives a summary of instances in which the Trust has had to respond to extraordinary circumstances.

#### 2. Background

- 2.1. The Civil Contingencies Act (2004) outlines a single framework for civil protection in the United Kingdom. Part 1 of the Act establishes a clear set of roles and responsibilities for those involved in emergency preparedness and response at the local level. As a category one responder, the Trust is subject to the following civil protection duties:
  - assess the risk of emergencies occurring and use this to inform contingency planning.
  - put in place emergency plans.
  - put in place business continuity management arrangements.
  - put in place arrangements to make information available to the public about civil protection matters and maintain arrangements to warn, inform and advise the public in the event of an emergency.
  - share information with other local responders to enhance coordination.
  - cooperate with other local responders to enhance coordination and efficiency.

#### 3. Risk Assessment

3.1. The Civil Contingencies Act (2004) places a legal duty on responders to undertake risk assessments and publish risks in a Local Resilience Forum Community Risk Register. The purpose of the Community Risk Register is to assure the community that the risk of potential hazards has been assessed, and that preparation arrangements are undertaken, and that response plans exist. The Trust's EPRR risk register mirrors the risks identified on the Community Risk Register that could impact human health and the acute sector.

#### 4. Assurance

4.1. Appendix 1 details the EPRR assurance logs for 2022/23 and 2023/24 YTD. These logs detail the publication dates of key EPRR documents and activities and the dates that they are due for release or review.

#### 5. Audits

- 5.1. In September 2022, Buckinghamshire, Oxfordshire, and Berkshire West (BOB), Integrated Care System (ICS) and NHS England undertook an audit of the Trust's EPRR arrangements, which took the form of a self-assessment audit. The audit noted that the Trust was fully compliant with all standards except two.
  - The first which was rated as partially compliant related to compliance with the Data Protection Toolkit (DSPT):
    - "Organisation's Information Technology department certify that they are compliant with the DSPT on an annual basis."
    - The Trust is not fully compliant with the DSPT in one area with relates to logging solutions. The Trust has an action plan in place to address this. Currently the Trust is in discussion with potential suppliers for a long-term logging solution. This is large projected due to the costs and infrastructure involved.
  - The second rated as partially compliant related to training for staff that are most likely to encounter patients requiring decontamination. This standard is rated as partially compliant due to staff turnover. A rolling training programme is in place to manage this.
- 5.2. The review was endorsed at the October 2023 meeting of TME. The self-assessment audit showed an overall rating of "Substantially Compliant".
- 5.3. This audit was repeated in September 2023 with BOB ICS. The audit noted that the Trust was fully compliant with all standards except two.
  - The first which was rated as partially compliant related to compliance with the Data Protection Toolkit (DSPT):
    - "Organisation's Information Technology department certify that they are compliant with the DSPT on an annual basis."
    - The Trust is not fully compliant with the DSPT in one area with relates to logging solutions. The Trust has an action plan in place to address this. Currently the Trust is in discussion with potential suppliers for a long-term logging solution. This is large projected due to the costs and infrastructure involved.
  - The second rated as partially compliant related to the decontamination unit at the Horton which had become damaged and beyond repair. A replacement unit has been delivered and training for staff undertaken. This item will become fully compliant pending the instalment of an adaptor to the water supply hose. This is expected to be by mid-December 2023.

- 5.4. The self-assessment audit showed an overall rating of "Substantially Compliant". The report of this review will be submitted to TME in a separate paper.
- 5.5. SCAS undertook a review of our preparedness to receive contaminated casualties in January 2023. The audit report showed an overall rating of substantially compliant.
- 5.6. BDO undertook an EPRR audit for the Trust which concluded in February 2023. The audit concluded substantial assurance for control design and moderate assurance over operational effectiveness. BDO made the following recommendations:
  - That services are reminded annually of the need to review and test their Service Continuity Plans (SCPs). This action was undertaken via the monthly EPRR report in March and April 2023, and reiterated in the March 2023 Health & Safety Report.
  - Plan owners should schedule review and test dates for their SCPs and inform the Emergency Planning Officer of these dates. The functionality to record this information was made available on the SCP Tracker in March 2023. So far, this measure has been ineffective with very low identification of review and test dates.

#### 6. Partnership Working

6.1. The Trust works in collaboration with a range of partner agencies through formal standing meetings and ad hoc arrangements. Formal committees of which the Trust is a member include several subgroups of the Thames Valley Local Resilience Forum most notably the Thames Valley Local Health Resilience Partnership (Executive and Business Groups). The Trust is also represented at the Oxfordshire Resilience Group. The purpose of these groups is to ensure that effective and coordinated arrangements are in place for NHS emergency preparedness and response in accordance with national policy and direction from NHS England.

#### 7. Debriefing from Live Events and Exercises

7.1. Following live events and exercises, debriefs are undertaken to capture learning points. Lessons identified from live events and exercises are subsequently incorporated into major incident and business continuity plans and are shared with partner organisations.


#### 8. Communications

8.1. Communication is critical in dealing with any incident. Several communications exercises have been held over the past 12 months with the last being held on 15 May 2023.

#### 9. Incident Response Plans

- 9.1. The Incident Response Policy outlines the structure and processes for Command and Control that will be used during a significant, business continuity, critical or major incident.
- 9.2. Version 1.2 of the Policy was released in July 2022.
- 9.3. The Incident Response Policy is supported by a suite of emergency preparedness plans to support the Trust in the management of untoward events. The following schematic details these plans:

#### Emergency Planning, Resilience and Response Plan Schematic



9.4. This suite of plans is in turn, supported by service level continuity plans. A rolling programme to maintain compliance to the Trust's standards in place. Appendix 2 shows the Divisions progress on their Service Continuity Plans. Currently, 18% of services are rated as red in their compliance to the Trust's standard for Service Continuity Plans.

#### 10. Policy Review

- 10.1. Following a review of the Trust Incident Response plans, the suite of plans has been updated, and drafts posted to the intranet for comments from May to July 2023. The Trust Board is requested to approve the following policies as part of the annual review process.
- 10.2. All of the plans have been updated to reflect the current Trust structure and further amendments. A summary of the amendments to the plans can be found in Appendix 3.

#### 11. Training, Exercising and Testing

- 11.1. The Trust has a rolling training programme along with a programme of live, table-top, command post and communications exercises. The exercises are designed to test and develop our plans. The Trust is required to hold the following:
  - Communications exercise minimum frequency every six months
  - Table-top exercise minimum frequency every 12 months
  - Live play exercise minimum frequency every three years
  - Command post exercise minimum frequency every three years
- 11.2. If an organisation activates their Incident Coordination Centre in response to a live incident, this replaces the need to run an exercise, providing lessons are identified and logged and an action plan developed. The live events detailed in section 12.
- 11.3. Appendix 4 details when OUH has enacted, trained, or exercised EPRR plans from April 2022 to November 2023.
- 11.4. To ensure that the Trust has appropriate leadership during incidents, the Trust audits the numbers of Duty Directors and Duty Managers that have received incident management training. This training is delivered through a range of methods from lectures, workshops, through to scenario based exercises. As of 30 November, 100% of Duty Directors and Duty Managers had received incident management training.
- 11.5. Whenever possible, the Trust strives to ensure that our testing is held in a multi-agency context. This is to provide familiarisation with other organisations and to assist with benchmarking our response with our partners. Exercises provide invaluable insight into the operationalisation of our plans and important information regarding the areas of the plans that require further development.
- 11.6. In addition to these, a rolling programme of service-level major incident and business continuity exercises have taken place. The need for improvement in the level of service-level training and exercising is recognised, and a programme to achieve this is in place.
- 11.7. A rolling programme of Major Incident and Decontamination Training for ED staff is in place.
- 11.8. Six monthly loggist training sessions are held, and another session is scheduled for January 2024.
- 11.9. The Managing the Health Response to Incidents course and Incident Management course have continued to be held six monthly for On-Call Duty Directors, Duty Managers, General Managers, Operational Services Managers, Matrons, Divisional Silvers, and Service Managers.
- 11.10. A regional exercise was held on 29 June 2023. The exercise looked at hospital evacuation. The exercise is currently being evaluated and a report will be available in due course.

11.11. As required by the EPRR Core Standards, all corporate-level training and exercising is based on and referenced to the National Occupation Standards for Civil Contingencies.

#### 12. Live Events

- 12.1. Appendix 4 details the live events that the Trust has had to respond to from April 2022 to October 2023. Links to the debrief reports from these incidents are included in the table.
- 12.2. A summary of the live events experienced is given below:
  - 17 September 2022 following the death of Queen Elizabeth II, there
    was a short notice bank holiday. This required the Trust to enact its
    business continuity plans to ensure that services were covered, elective
    and outpatient cases rescheduled, and contingency arrangements put in
    place.
  - 5 October 2022 TSSU at the JR received their annual IPC lab results back stating that the endotoxin reading for the steam header was above the acceptable level. External advice obtained by TSSU provided the opinion that JR TSSU cannot process any Neuro, Spinal, Ophthalmology or Craniofacial kits (any kits that may be used on work impacting central nerve system), because of a risk of adverse reaction during surgery for a group of these patients. Contingency planning for JR TSSU was to send their kits to Royal Free Trust and to decant some work to the NOC TSSU. Estates undertook the necessary decontamination of the plant.
  - 7 October 2022 a letter from NHSBT notified Trusts of Low Red Cell Stocks for transfusion and on 12/10/22 NHSBT made the formal declaration of an Amber Alert. The Trust activated an Emergency Blood Management Committee (EBMC) which meet regularly to ensure that appropriate actions were taken within the Trust to manage stocks and support national supply management. The group was stood down following the notification from NHSBT that the position will move to a preamber alert on 8/11/2022.
  - 2 December 2022 the Trust Multiple Trauma plan was activated in response to a multiple car road traffic collision on the Gloucestershire/Oxfordshire border. South Western Ambulance Service (SWAS) responding as the lead ambulance service but requested mutual aid from South Central Ambulance Service (SCAS).
  - 2 April 2023 the Trust face approximately 3 hours unplanned EPR downtime. The Trust had to convert to the continuity arrangements of using paper based documentation during this period to ensure patient care could continue.
  - The Trust has responded to several rounds of industrial action since
    December 2022. This has required the Trust to enact its business
    continuity arrangements to ensure critical services are provided. This has
    required some less critical activities to be reduced or stopped during the
    period of strike action. Industrial action that has required these
    arrangements to be put in place are listed below.

- 15 and 20 December 2022 RCN Strike Action
- 6-7 February 2023 RCN Strike Action
- 13-16 March 2023 BMA/HCSA Strike Action
- 11-14 April 2023 BMA/HCSA Strike Action
- 30 April-1 May 2023 RCN Strike Action
- 14-17 June 2023 BMA/HCSA Strike Action
- 13-18 July 2023 BMA/HCSA Strike Action
- 20-21 July 2023 BMA/HCSA Strike Action
- 11-15 August 2023 BMA/HCSA Strike Action
- 24-25 August 2023 BMA/HCSA Strike Action
- 19-22 September 2023 BMA/HCSA Strike Action
- 2-5 October 2023 BMA/HCSA Strike Action
- 28 June 2023 a power outage experienced in the Headington area affected the NOC, JR, and CH sites. Generator back up came on line to JR, CH and approximately half of the NOC site. Generator power did not come online to the other half of the NOC site. This resulted in approximately 2 hours with no power to this part of the building. Generator power restored was then restored to this part of the site, but the area remained on generator power for the following 2 days until full remedial work could be completed.
- 1 October 2023, the Churchill retained estate was affected by a power cut that resulted in 2 of the 8 generators not activating. This resulted in nearly 4 hours loss of power to some areas of the retained estate.
- 25 October 2023, the Trust activated its Paediatric Multiple Trauma Alert plan in response to a road traffic collision in the Oxford area. 10 patients were brought into the Emergency Department. This was declared a critical incident.
- 9 November 2023, the Trust supported Oxford Health NHS FT in providing emergency shelter for patients from the Fulbrook Centre that required evacuation following an electrical surge that caused widespread electrical damage across the unit.
- 12.3. After these events debriefs were held to ensure that any learning from these events could be captured and used to inform future planning. Links to the reports and learning points are provided in Appendix 4.

#### 13. Conclusion

- 13.1. The past year has seen good developments in the Trust's resilience arrangements; however, more work is required at the service level to achieve full resilience.
- 13.2. The Trust should be undertaking a more detailed and comprehensive training and exercising programme; however, this requires resourcing.

#### 14. Recommendations

- 14.1. The Trust Board is asked to:


